Program Expectations:

1. Roles & Responsibilities – The Mentoring Pastor serves as the primary educator for the Apprentice Preacher under the Seminary Apprenticeship program. Therefore, the Mentoring Pastor is expected to take an active role in educating the Apprentice Preacher, and the Apprentice Preacher is expected to take active role to learn. The Seminary Apprenticeship program is designed to provide a structured environment to support the education and training of the Apprentice Preacher. The Seminary Apprenticeship program is not designed to function as a third-party that independently educates the Apprentice Preacher, as you would expect in a traditional Seminary school. It is vital that the Mentoring Pastor fully embraces the mentor role and actively works to educate & train the Apprentice Preacher.

- 2. Monthly Certification Card Upon entering the program, the Apprentice Preacher will be issued a Monthly Certification Card. The Monthly Certification card outlines and tracks the monthly participation requirements. The Apprentice Preacher is required to maintain a Monthly Certification Card, signed by Mentoring Pastor, each month for 36-months. This Monthly Certification Card represents OJT hours and therefore, the Mentoring Pastor may require additional months if it is determined that the Apprentice Preacher needs more time in the program.
- 3. 3-Yr Certification Card Upon entering the program, the Apprentice Preacher will be issued a 3-year Certification training card that outlines all the requirements to graduation from the Seminary Apprentice program. At the end of the 36-month participation, the Mentoring Pastor, who serves as the primary educator of the Apprentice Preacher, will determine and certify that the Apprentice Preacher has completed the Seminary Apprenticeship program requirements and will be the signature authority on the Certificate of Completion.
- 4. Non-Doctrinal Training Modules As we discover with many things in life, we don't know what we don't know. These Non-Doctrinal Training Modules are designed to assist you in whatever depth of knowledge you consider may be relevant to conduct the ministry. However, from experience, these Training Modules are necessary ministry skills & tools, but it is up to each Pastor to determine how much training and education they may require. Mentoring Pastors can add, change or remove any training topic they feel is unnecessary in the education of the Apprentice Preacher to complete the 3-yr Apprentice Certification.
- 5. <u>Graduation Requirements</u> The Seminary Apprenticeship program is designed to be completely autonomous. Therefore, the Mentoring Pastor is the primary educator of the Apprentice Preacher, the Mentoring Pastor will determine when the Apprentice Preacher is ready to graduate from the program.
- 6. <u>Disagreements</u> The Seminary Apprenticeship is structured to provide an atmosphere of learning by the participants. All participants are encouraged to function as willingly engaged learners, presenting themselves as open to education.
